### Survey Methodology



ALG Research conducted statewide surveys of N=600+ registered voters in Arizona, California, Georgia, Nevada, New Hampshire, Pennsylvania, and West Virginia. The total sample size across all states is N=4,262



Interviews were conducted February 19-25, 2021.



This survey was conducted online, sent via email and SMS. The 95% confidence interval for the project overall is +/- 1.5%. For California, the 95% confidence interval is +/- 3.82%, and +/- 4.0% for every other state.







### POLITICAL LANDSCAPE


### President Biden's job rating is above water in battleground states – and only underwater in West Virginia.

Biden's approval ratings are still fairly soft in this early juncture, as more voters rate him "good" rather than "excellent."




### The president's positive rating is driven by strong support among voters of color.

Self-ID Independent voters are fairly split on Biden's early job performance.




Each Democratic senator in AZ, CA, and GA have positive job ratings, but only newly-elected Mark Kelly is outpacing Biden's numbers in their home state.

Gavin Newsom's job rating is 12 points underwater and 40 points behind President Biden's in CA.



Senators Cortez Masto, Hassan, Moore Capito, and Casey are all above water on approval, but below 50% positive overall.

The job ratings of Toomey and Manchin are both deeply negative, while Governor Sununu continues to be among the nation's most-liked governors.

### **ECONOMIC RECOVERY**

### A plurality of voters in each state believe sending additional stimulus checks to households is the most important part of an economic recovery bill.

Additional checks are seen as the most important component of the bill by at least a 2-to-1 margin over the other potential elements.

### Voters place far less importance on issues outside of stimulus checks, infrastructure, or boosting domestic manufacturing.

## Additional stimulus checks are the top priority across the partisan spectrum, even among a plurality of Republicans.

White women and voters of color are among the most likely to mention additional checks.



### **RECURRING CHECKS**


## Majorities in every state support issuing recurring payments until the end of the public health emergency.

Not only are recurring payments popular – they have intense support across these states.



Democrats, African Americans, and Latinx / Hispanic voters overwhelmingly support recurring payments.

Independents are 2-to-1 in favor, while Republicans are closely divided. Voters who expect to receive another check are net 52-points more supportive than voters who don't expect a check.



## Strong majorities favor having recurring payments tied to economic indicators, rather than leaving the decision to Congress.

# Even across partisan and racial divides, voters prefer recurring payments being tied to the economy.

## Voters believe working-class and poor Americans should be eligible for these checks – not the wealthy or upper-middle class.

Opinions are more divided as to whether or not middle-class Americans should be eligible.

## Strong majorities across ideologies and demographics support recurring checks going to working-class and poor Americans.

## More than 40% of recipients say a \$1,400 check would last them a month or less, and 70% say less than three months.



#### RECURRING CHECKS MESSAGING



#### **Positive Messages Tested**

[HOUSING] Millions of Americans are unable to pay their rent or mortgage due to the impacts of this pandemic. Providing regular survival checks protects families from evictions and foreclosures, helping to keep families out of poverty.

[BASIC NEEDS] Regular survival checks are a way to help struggling families take care of their basic needs – so more people can get back on their feet and make it through the current recession.

[WORKING-CLASS] Regular survival checks help working-class people like waiters and hairdressers, and even small-business owners who are struggling to make ends meet.

[CRACKS IN UI] During the current pandemic and recession, two-thirds of working-class Americans who have lost income haven't received unemployment benefits. Regular survival checks help make sure more families don't fall through the cracks.

[SMALL BIZ] Providing regular survival checks will allow families to buy the things they need, which boosts small businesses and will prevent layoffs until the economy gets back on track.

# All positive messages work with similarly strong efficacy, but Housing is slightly more convincing and our best framework overall.

## Housing is the most effective message across the board, especially with people who become move supportive of recurring checks during the poll.

Gainers (whom we pick up during the poll) are disproportionately white women 50+, white Democrats 50+, white Republican women, and moderates.

### Voters were shown the following negative messages in opposition to recurring checks.

#### **Negative Messages Tested**

[DEBT] This plan adds trillions of dollars to the national debt that our children and grandchildren will have to pay back.

[**DISCOURAGE**] Issuing regular payments with no strings attached will discourage too many people from finding work and contributing to the economy.

[CHINA] Giving out regular payments will put us hundreds of billions of dollars further in debt to countries like China.

[RECIPIENTS] Giving out regular checks would give money to many people who are still employed and don't need help.

**[UNSPENT]** The previous stimulus dollars are not yet fully spent. We shouldn't be handing out even more money before the previous funds are used.

While none of the negative messages are as convincing as any of our positives, the debt argument tests with a bit higher potency.

Not surprisingly, the debt message plays well with Republicans and white men – as well as those who don't expect to get a stimulus check.



#### POST-MESSAGING SUPPORT

Opinions on recurring checks remain strong and resilient throughout message testing. Even when voters only hear opponent attacks, a majority still supports recurring checks.

Strong intensity in support of recurring payments holds steady. Most voters understand the issue and have chosen a side – most often ours.



Voters in Georgia and Nevada are the most persuadable to messages from either side. But like voters in the other states, they revert back to their original viewpoint after hearing from both sides.

We lose a little ground among African-American and Hispanic voters, but there's minimal movement overall after respondents hear from both sides.



### **ADDITIONAL QUESTIONS**

There is strong support for raising taxes on millionaires. Voters also support repealing the Trump/GOP tax cuts by a 2:1 margin.

Both initiatives have clear majority support when framed as an effort to pay for recurring relief checks.



#### Both measures are strongly supported but raising taxes on millionaires has a much large base of support.



### CONCLUSIONS

### Poll Takeaways

- Americans strongly support recurring stimulus checks, tied to the public health emergency or to economic conditions, by a nearly 2-to-1 margin. They understand the issue, and there isn't much room to convince them otherwise. Majority support for recurring checks holds throughout message testing even after negatives and there is a powerful political argument for making checks automatic rather than leaving them up to Congress.
- Voters prioritize additional stimulus checks by at least a 2-to-1 margin over the other potential elements of a recovery package.
- We have better messaging arrows in our quiver than our opponents. All our tested messages are more convincing than the negative messages tested. As we make the case for recurring checks, housing should be part of our go-to message frame. It's the most-effective positive overall and among the gainers we pick up during the poll.
- Voters of color begin and end as strong supporters, though they are more persuadable.
- Potential persuasion targets are broad but our messages are effective across the board. Most groups and demos shift when they only hear from one side or the other but largely revert to their original position once they hear from both sides. Gainers are disproportionately white women 50+, white Democrats 50+, white Republican women, and moderates.
